Minor Tenant Improvement Funding Extension

We are pleased to advise that the GPSC has approved the extension of Minor Tenant Improvement (MTI) funding to FY2o21/22. Jointly funded by the BC Ministry of Health and the GPSC, the MTI funding is available until March 2o22, to support family physician owned/leased clinics in expanding and/or renovating existing or new space to accommodate new team members (RNs/LPNs and/or AHPs), as indicated in service plan approvals. All applications for the funding must be submitted by December 31, 2o21, with the work to have been completed by March 31, 2o22. Funding is available until March 31, 2o22 or when the total funding amount has been exhausted (whichever comes first). New GPSC Grant Supports Doctors to Form Group Family Practices

The GPSC has introduced a new grant to help cover expenses incurred when family doctors join or form a new or expanded group practice. The Group Family Practice Development Grant, which provides up to \$30,000 per eligible physician, addresses feedback from family doctors that significant expenditures of closing and/or merging offices are holding them back from forming or consolidating group practices

Doctors of BC Confidentiality Agreement for Health Authority Employees Working in a Physician's Private Practice

New Care Team Members working in a Physician Clinic will be asked to sign a confidentiality agreement that acknowledges their need to fully comply with the Personal Information Protection Act (PIPA) as directed by the Physician Practice Policies. No action is required on the Clinic's part at this time. Once this document is signed by the Care Team Member working with the team and in your practice, a copy will be provided to you. You can find an example of this document here.

Team Charting Agreement

The Team Charting Agreement is an agreement used when Care Team Members employed by a Health Authority chart within the Primary Care Practice Electronic Medical Record. This agreement was developed by the GPSC for use by Primary Care Networks. We will be providing a "How To Guide" to support clinics to complete this agreement.
