EK Division Update:

- Capasiti Consulting in Fernie was awarded the contract for scoping a Community Health Centre in Fernie. This is the first step to developing a potential business model to co-locate primary care services in the community. The funding has been provided by the Rural Coordination Centre of BC for PCN planning support.
- New opportunity Are you interested in joining the Psychiatric Unit Inpatient Call Rotation in Cranbrook? They are seeking a GP who is interested in joining the rotation 5-6 times per year. Payment is by sessional, and you would need to be local to Cranbrook to meet the level 2 MOCAP requirements (attendance at the site), or there may be some opportunity for accommodation to be provided, if you are from out of town. - PCN update The Ministry of Health has developed a new policy framework for rural PCNs in BC. We are currently waiting for feedback on our proposal submitted in July, and how this new Framework aligns with the proposal.
- New information on hiring of RNs in PCN BCNU has agreed to allow for interviewing for primary care positions, as well as to ban bumping with those positions. This is good news for stability of the teams and physician input into the selection processes.

Advancing team-based care in the East Kootenay

Across BC, work is underway to transform the primary care system through the expansion of team-based care.

For Dr. Todd Loewen, a family doctor in Fernie, B.C. and the Physician Lead for the East Kootenay Division of Family Practice (EK Division), this shift towards team-based care is an affirmation of the principles that he and other rural family physicians practice on a daily basis.

"In the smaller communities, where family doctors provide the full spectrum of acute and community care, and where resources are often limited, we've had to learn how to work collaboratively and creatively," he says.

develop a number of team-based initiatives in the East Kootenay, including the primary care social work program, and is initiating planning for a community health centre for Fernie.

Through the primary care social work program, developed by the EK Division of Family Practice and the Ktunaxa Nation, family doctors and Band health centres across the region now have access to social workers dedicated to supporting patients with complex needs.

"We know that social determinants like poverty and access to housing have a direct and profound impact on patients' health," says Dr. Loewen. "The addition of social workers to the primary care teams means patients needing support are more easily connected to community services, freeing up doctors to focus on their patients' medical treatment."

The proposed development of a community health centre in Fernie is another initiative that will advance team-based care. Once built, the centre would bring together a wide-range of health and social services in one central community location.

"Bringing health care, social work, counselling, pharmacy and other services, together, under one roof, has huge benefit for patients – especially those who are elderly or require extra support," says Dr. Loewen. "It also provides greater opportunity for team work among practitioners, resulting in more coordinated, comprehensive care."

Under the province's new health care strategy, Dr. Loewen is hopeful that team-based care will strengthen local services across the province, making it easier for patients and providers to navigate the system.

"There are still people in our province who are being left out of proper, comprehensive care, either because they don't have a family doctor, or they can't access necessary services," says Dr. Loewen. "If properly implemented and supported, team-based care has the potential to connect more people to the care they need".

The Ministry of Health has informed us it intends to offer new **Alternative Payment contracts** to full service family

physicians who are currently involved in developing Primary Care Networks. This contract would be a complement to the contract it developed for new-to-practice GPs.

It is essential that physicians are engaged in the development of these new contracts and their input provided. At the September 20th Doctors of BC Board meeting, the Board appointed five members to a new Alternative Payment Committee that will consult with government on the development of this new model of compensation – a process established in the Physician Master Agreement. Some members have been asking for a change from the FFS model, so as we move forward in a careful and informed way, we will ensure physician interests continue to be protected.

Please note that this is a consultative process. At the end of the day, the Ministry has the right to offer any new contract to physicians which does not conflict with the Physician Master Agreement, and it will be up to each physician to decide. Doctors of BC's goal is to do its best to ensure that the end result is a contract that is fair and reasonable for our members.

He is currently a Critical Incident Stress Management Trainer, Counsellor and Consultant in private practice, Bruce is an Aboriginal person (Métis) as defined in the Canadian Constitution and has worked in First Nations (Canada) and American Indian communities over the last twenty-five years providing CISM training to Mental Health Professionals, Counsellors, Tribal Police and community front line responders.

The Traumatology Institute of South Florida University recognizes Bruce as a Certified Traumatologist. He is also a Certified Trauma Responder with the Association of Traumatic Stress Specialists and is a past Vice President of that organization. He is a well known speaker on the management and development of trauma services, having presented on behalf of the Justice Institute, First Nations' Emergency Services of BC, the Yukon Aboriginal Health Program, BC Fire Chiefs Association, Aberdeen Indian Health Services, Oklahoma University Health Promotions, Aramco-Saudi Arabia and on several occasions at the International Critical Incident Stress Foundation (ICISF) World Congress on Stress, Trauma and Coping in the Emergency Professions.
