Moving Forward Together

On November 3, 2017, the GPSC's Incentives Working Group and the Team-based Care Task Group met with division representatives and health authority partners to discuss emerging ideas for supporting patient medical homes and primary care networks. These emerging ideas had evolved from a variety of sources, including GPSC Visioning, working group and GPSC discussions, A GP for Me reports, and GPSC Summit discussions. Participants also discussed opportunities and challenges of implementing team-based and networked care.

Informed by this discussion, the Working Group and Task Group then convened on

Health Consultant available to work with GPs

Health Consultant (HC) is available to work with GPs to support **adult patients with complex needs related to social determinants of health and MHSU issues. Why refer to the HC?** The HC can offer short term (1-5 appointments) to help your patients to:

- * Identify/clarify presenting and underlying social issues/needs affecting their health
- * Navigate and connect to community health and social services (e.g., legal, employment, housing, benefit entitlement, MHSU groups and services etc.)
- * Support with suggested care/self-management plan

Reminder to submit GPSC Portal Fees ~ G14070 & G14071

GPs are reminded to submit the GPSC Portal (G14070) or GPSC Locum Portal (G14071) fee at the start of the new year. Effective **January 1, 2018**, GPs will need to bill G14070/71 in the following way to avoid billing refusal. Changes for 2018 are highlighted in **red**.

CYMHSU Referral Helper is Live

The Child and Youth Mental Health and Substance Use Referral Helper is an online resource developed by the Campbell River and District Division of Family Practice under the **CYMHSU Collaborative** to support clinicians in discharge planning for children and youth who present to the Campbell River Emergency Department. Designed for use by Physicians, Medical Residents, Locums, Crisis Teams, Social Work and Aboriginal Health; it can also be used by other professionals needing information on resources and referral pathways to CR Community services including island-wide resources for Aboriginal services.

The tool has 4 main referral streams: **Mental Health; Substance Use; Sexual Assault; Child Protection**

Based on the referral stream selected, the Referral Helper presents the user with a few short questions and then proposes the most appropriate referral options. Supporting documents such as assessments and screening tools are organized by referral stream for easy access and reference if required by the clinician.
