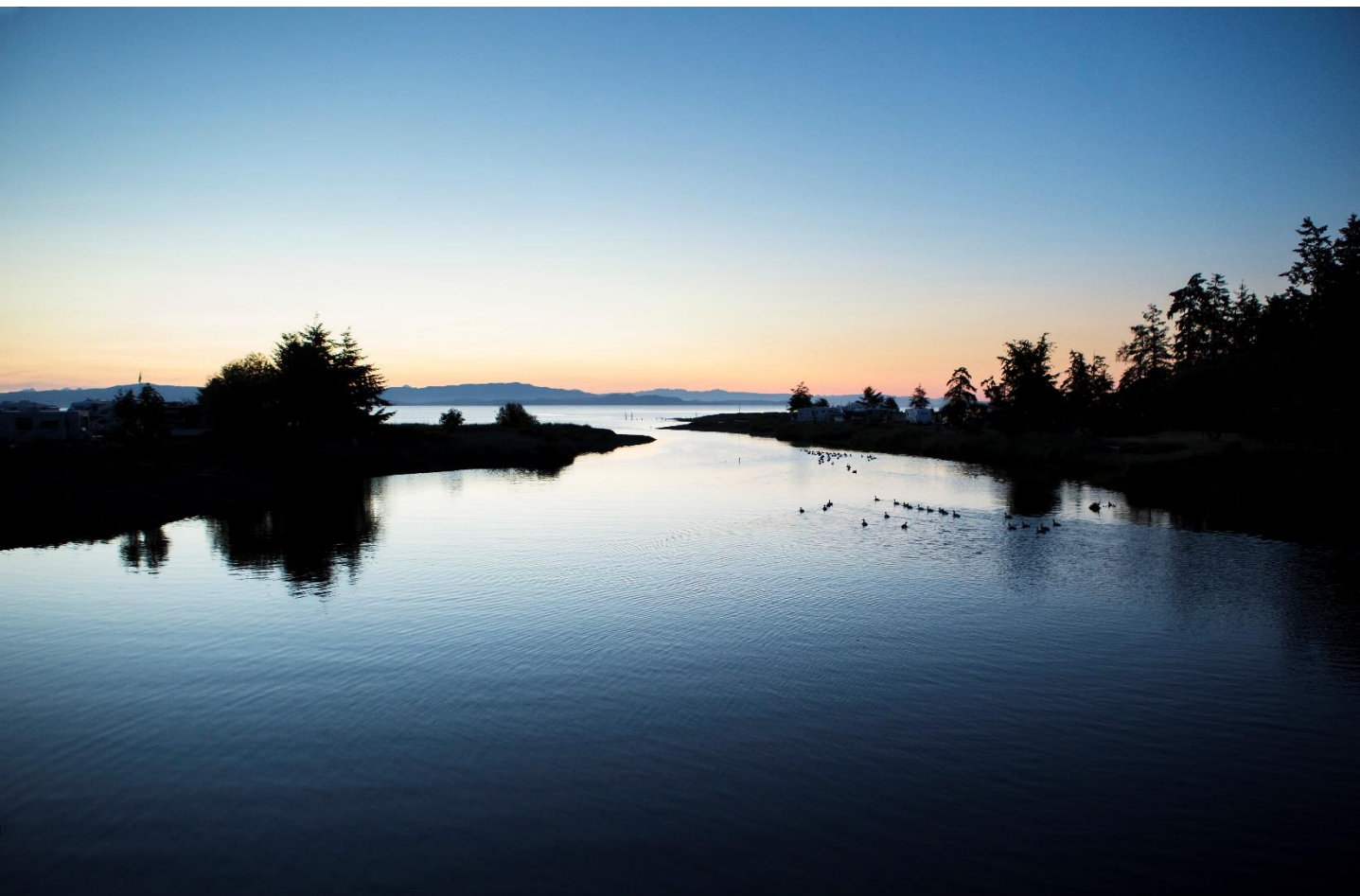

Co-Chair's Report

The 2022 Annual Report will reflect a year of changes within Central Island Division, the expansion of staff and involvement of Board members in several committees tied to over 12 projects. With project expansion the Board's fiduciary responsibility included oversight of a ~\$1.5M budget and balance of same.

As well, the Board engaged Brian Evoy to guide Board and Division members through a strategic planning session with follow up meetings to respond to the main focuses of the plan. They are: Engaging members in explaining the purpose and vision of our Division, and both social and working engagement events to better understand the LFP model and retirement preparation, as well as a social event to celebrate Division growth and accomplishments.

Here are a few more Board activities for the 2022 fiscal year:

- Oversight of funding returns to FPSC at the termination of the Physician Master Agreement (PMA), development of a new Memorandum Of Understanding (MOU) for Long Term Care, and support of a new West Coast Hospital inpatient Bridge Funding project.
- Coordinating a Bylaw review and update, as well as service on the Communications, Qualicum Clinic, and Election sub-committees
- Strengthening of relationships with PCN partners including Island Health, local First Nations, First Nation Health Authority, Metis Nation, community groups and local governments
- Strengthening of relationships with all BC Divisions through involvement with: Network of Rural Division, Family Practice Services Committee (FPSC), and Doctors of BC (DoBC)
- Board involvement the Collaborative Services Committee (CSC), Primary Care Network (PCN) Steering Committees, Rural Coordination Center BC, Long-term Care Leadership, and Van Isle Interdivisional Strategic Committee.

The Board would not be able to continue this work without the support of our community. The Board would like to publicly thank our talented hard-working staff who come to work every day and work hard to make our family practitioner's life a little easier.

We would also like to thank our members, community, and partners for helping in this success. The velocity of change is increasing in our world and reshaping the medical system and players. Physicians and nurse practitioners who flourish in the face of change are the ones who are open to learning while embracing new opportunities.

Executive Director's Report

The 2022/2023 year came with an end to the old Physician Master Agreement (PMA) and a new PMA along with the introduction of the Longitudinal Family Practice opportunity. At the Central Island Division we experienced staff turnover and expansion, project expansion and a new Primary Care Network (PCN) project in Port Alberni and surrounding areas. With these new opportunities came the challenges of starting up new projects while maintaining ongoing projects.

Major areas of focus for Central Island Division staff this year have been:

- Acceptance from the Ministry of Health of a Service Plan for PCN in Port Alberni
- Hiring of staff for PCN in Port Alberni
- Involvement in Collaborative Services Committee (CSC) and PCN Steering Committees in both Oceanside and Port Alberni.
- Involvement with the Interdivisional Strategic Council, Island Collaborative and Rural Coordination Centre
- Hiring of a new Operation/Recruitment coordinator
- Roll out of 7 new projects. Those being:
 - Maternity Care in Port Alberni
 - Shared Care Remote First Nations Support
 - Health Emergency Management
 - Perinatal Support project
 - Physician Engagement and Retention
 - West Coast Hospital In Patient Bridge Funding
 - Physician Engagement in PMH/PCN
- Continued support of 5 projects. Those being:
 - HPV Pilot Project
 - Long-term Care initiative
 - Oversight of Minor Tenant Improvement funding
 - Qualicum Community Clinic Pilot project
 - Patient Attachment Mechanism
- Funding received for project in 2021 was ~\$1.2 M. Funding received in 2022 was ~\$1.5 M. An increase in the budget of \$300,000

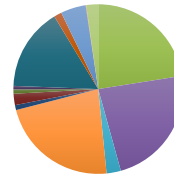

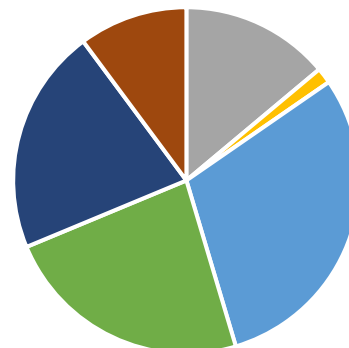

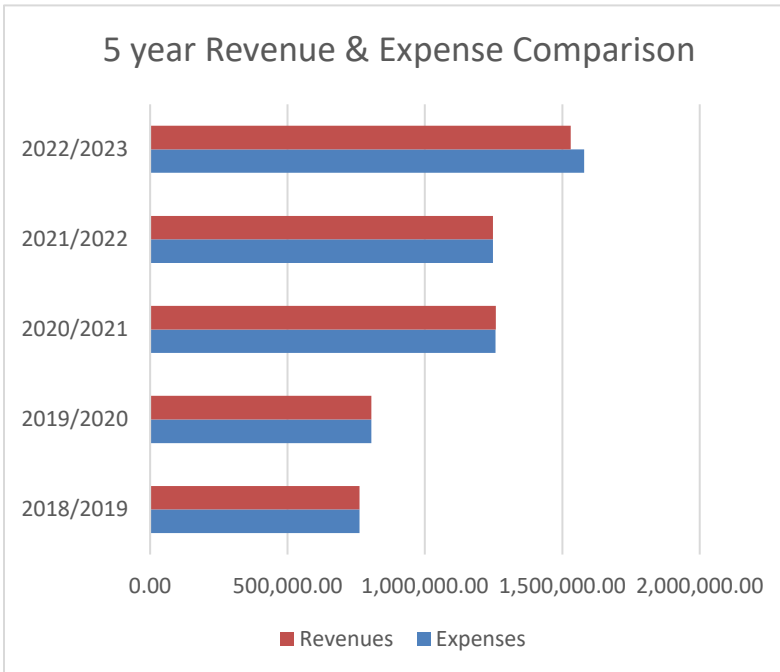

Oceanside Primary Care Network

This last year was full of momentum for the Oceanside Primary Care Network (PCN). Service Plan implementation continued, stakeholder partnerships strengthened, and improving access to team-based primary care drove our passion and commitment to this work.

Some highlights:

- Mid Island Métis Nation joined our Steering Committee as a voting member.
- The Primary Care Clinical Pharmacist continued to spend half a day every two weeks with each of our PCN practices.
- Expressions of interest were offered to our PCN practices to add a social worker (SW) in practice to their team-based care compliment. Two SWs were mobilized to four practices.
- The registered nurses (RN) in practice continued their good work in the clinics.
- A Sni'wut (Helper) was hired. He spends his time in service to Qualicum First Nation and Snaw-Naw-As First Nation.
- An Evening of Conversation was hosted at the Qualicum First Nation. Elders shared their health care stories, experiences, and visions for change. Brushing was gifted to participants throughout the evening.
- The rural clinic floorplan was finalized.
- Evaluation frameworks were developed with consultants from Reichert and Associates to support the ongoing evaluation of the PCN. A clinic support staff survey was circulated in fall, and a patient evaluation was completed in spring.

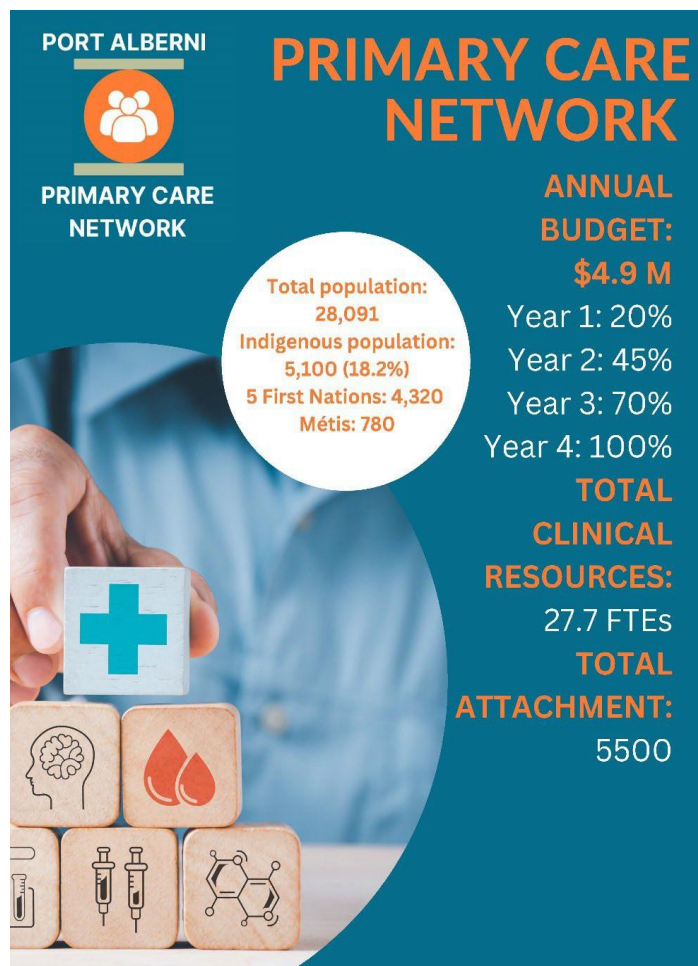


Port Alberni Primary Care Network

The long-awaited Port Alberni Primary Care Network was approved in February 2023, with all 5 strategies submitted in the initial service plan given the go-ahead to begin operationalizing in 2023.

With early draw funding approved for January 1, 2023, the Port Alberni PCN hired PCN Manager Sharon Todd to begin working with our primary caregivers, Indigenous partners, and Island Health team.

Early draw funding also awarded 2 RNs in practice, with both hired and resourced into practices within the first 90 days of the PCN early start date.



The Port Alberni Primary Care Network has been approved to deliver 5 strategies to address shortfalls in primary care in the Alberni Valley.

1. An **Urban Indigenous Community Health Centre** will address the social determinants of health while incorporating traditional Indigenous practices to create a culturally safe space for low-income, street-entrenched, Indigenous, and non-Indigenous patients.
2. **Team Based Family Practice** will place 5 RNS and a pharmacist in Port Alberni family practice clinics, building capacity for attachment.
3. A low-barrier **MHSU Clinic** housed within the community health centre will address gaps in MHSU services.
4. A remote/street outreach **Mobile Health Unit** will bring our new teams directly to those currently without access to care.
5. A **Métis Health Advocate** will support the Métis community to build relationships, strengthen engagement and facilitate meaningful attachment with primary care providers.

Projects

Central Island Division of Family Practice (CIDFP) Patient Medical Home (PMH), Shared Care, Maternity and Nuu-chah-nulth and Coast Salish Engagement

CIDFP has been very active in the last year planning and implementing PMH Innovation, a Maternity Network, 2 Shared Care Projects, and First Nation outreach. Each project has looked at leveraging existing resources, and creating functional teams who care for our complex demographic. Some of the activities:

- In collaboration with Island Health, 'Community Virtual Care' Continuing Medical Engagement (CME) session was held for our members to learn about the services provided and available for them to refer their patients to.
- FPSC Maternity Care Network continuation in Port Alberni with a one pager distributed to all GP offices for providers and families that are looking for support. Maternity community also added Oceanside to the Network with Dr. Kelly Hadfield practicing perinatal care in the community.
- Shared Care Oceanside Psychiatry Network established throughout 2021/2022 with funding ending in June 2022. Psychiatrist, Dr. Samantha Saffy and a total of 6 GPs and 4 NPs were a part of the shared care sessions in clinic on approaches to psychiatric care. Dr. Saffy also offered her services to Snaw-naw-as health care centre. Providers have continued to meet in this model and have found a way to make it sustainable after the funding cycle ended.
- Dr. Saffy also offered a CME for providers on ADHD. It was called 'The ABC of ADD.' This topic was a request from members. This was offered in partnership with RCME funding via Island Health.
- Shared Care Port Alberni – Building a healthcare team with remote First Nation communities. Dr. Ian Warbrick is the lead on this project with full funding coming through in Spring 2023. This project aims to give support to remote community members in 4 Nations with complex chronic conditions via a team-based care approach, with an Internist, GPs, and the Nuu-chah-nulth nursing team. We have 4 Specialists involved and 3 GPs, both on the west coast and in Port Alberni.
- First Nation engagement sessions with Nuu-chah-nulth Elders and Port Alberni physicians, funded by RCCBC, until June 2022. The purpose: to develop relationships and collaborate on cultural safety and humility training and encourage candid discussion regarding reconciliation in healthcare.
- A celebration feast in Port Alberni was a culmination of the 9 zoom sessions held during COVID. Further sessions held in July and September 2022, as well as a dinner in February 2023.
- Oceanside First Nation (FN) Engagement held with 2 Nations, Snaw Naw As and Qualicum First Nation. An in-person event was held June 2, 2022, at Qualicum First Nation. RCCBC funding to run cultural safety sessions in Oceanside for above.

Programs Report 2022/2023

Health Emergency Management

Working with the West Memorial Clinic in Parksville, Central Island ran a clinic pilot program to prepare primary care offices for many types of emergencies. Clinics were provided with guides and books to prepare their plan, and upon completion, were awarded with a \$500 stipend, as well as a Grab and Go Trauma Kit to add to their emergency supplies. 11 clinics took part, and the feedback was excellent.

Physician Recruitment & Retention

In 2022, Oceanside welcomed 1 new family physician into part-time practice in Qualicum Beach. In January 2023, Jennifer Taylor took over the physician recruitment and retention program. Port Alberni welcomed one new full-time physician taking over for a retiring physician. Partners at Island Health, Doctors of BC, local Port Alberni physicians and NPs and the Central Island Division of Family Practice supported the new physician through this practice transition.

MOA Network

The MOA Network, consisting of members from Parksville, Qualicum and Port Alberni continued to meet throughout the year. Expressing a need for relief workers to cover solo physician practices, the newly formed Port Alberni PCN polled physicians to ascertain interest in using such a program to cover illnesses or holidays, but unfortunately did not receive enough interest to sustain such a program. In March, the new Operations and Recruitment lead worked with Suzanne Beyrodt-Blyt at Doctors of BC practice support to deliver a PCN billing training module to interested MOAS.

Vancouver Island Recruitment Collaborative

Our Central Island region rep attended both the Rural Health Conference in Penticton and St. Paul's CME conference in Vancouver with the VI recruitment collaborative in 2022 to represent islanddocs.com.
