Pharmacy in Practice Drug Shortage Update

Fluorouracil 5% (Efudex®)

Shortage Status: Expected Resolution: End of July 2025 Alternative: Fluorouracil 4% cream (Tolak[®]) has been listed as a temporary benefit on PharmaCare. Actinic keratosis of the face, scalp, ears Imiquimod 5% -Superficial basal cell carcinoma

Sulfamethoxazole/Trimethoprim (400/80 mg, 800/160 mg)

Shortage Status: Expected Resolution: May 2025

Alternative: Temporary coverage of compounded capsules has been allowed on PharmaCare. Requires a compounding pharmacy capable of producing capsules.

Consult Bugs and Drugs for treatment alternatives for specific infections

Testosterone

Shortage Status: Expected Resolution: Testosterone cypionate: Some brands expected back by end of June 2025; others uncertain Testosterone enanthate: Limited supply (Hikma brand)

Alternative: 1% gel available. No direct conversion going from IM injections to topical agents.

Some strategies for conversion include: a) start at a similar point in dosing range

b) Starting at a lower dose in the dosing range <u>Click here for more information</u>

Chlorthalidone

Shortage Status: Expected Resolution: June 2025

Alternative: An alternate thiazide or thiazide-like diuretic can be used(Indapamide, hydrochlorothiazide) No direct dose conversion-select a dose in a similar point in the dosage range.

Hydrocortisone Suppositories

Shortage **Status:** Proctodan HC, Anusol HC, Anodan HC expected by late May/early June (suppositories available: hydrocortisone, dibucaine, esculin, framycetin)

Alternative: Cream versions of the shortened suppository still available

for a permanent provider.
