President's Reports

It has been my privilege to serve the Mission Division of Family Practice as lead physician for the year 2012-2013.

We have had an eventful year, with some successful projects which have supported our member physicians in their continuing provision of full service medical cover in our community.

One of the new programs is the Doctor of the Day program. This has permanent funding through the GPSC and MSP and has attracted physicians back to providing sustainable in-hospital care services to our patients. The balanced funding model was developed by the members of the Division and is quite unique to Mission.

MDOFP successfully applied to the Ministry scheme for a funded primary care Nurse Practitioner. The NP will report to FHA, but is charged with working closely with the Division and will aid in discharge planning and care for unattached and vulnerable patients from both inpatient and ER.

MDOFP continues to support CME activities in Mission to improve local access to ongoing professional development for our members.

Looking forward, we are working towards the attachment of patients to community physicians, through the GP4ME program which is being offered on a provincial-wide basis. To date, Mission has completed its letter of intent to participate in the program and to formalizing more concrete plans to bring the benefits of the program to Mission.

MDOFP has also registered its interest in working with a new GPSC/MOH review of the physicians' participation in patient care at the residential care homes – in the same way that we worked on the GPSC/MOH review of in-patient care at MMH. Some of our members have continued to provide care for their patients who had been transferred to Ebenezer Home in Abbotsford during the development of the new care facility being built behind the hospital and their experience will guide the creation of a properly compensated care model, to be available when the new Mission residential care facility is opened in 2014.

I am personally very proud of the work that the MDOFP has accomplished over the year and would like to extend my appreciation to the work and efforts of all our Board members: Carol, Peter, Jeff, Sohan and Gerry, and also to Jonathan, our Executive Director.
