Clinic and Provider Registry (CPR) Payment \$2000

Medical Director or delegated physician claims the payment on behalf of the clinic.
Funding to register the clinic and update all the providers working there and updates.

Panel Submission and Registry Payment \$6500

Funding to support family physicians to develop and submit their panel/list and updates.
Any family physician who provides longitudinal family medicine to a patient panel

Panel Submission and Registry Highlights

- Not eligible if solely episodic or focussed exclusively
- Deadline for claiming the CPR payment? Same answer....
“not yet been confirmed”
- Commitment to updating the panel (office workflow?)
- Can only bill one, even if you have panels at multiple locations

Do physicians need to have a minimum number of empanelled patients to be eligible for the Panel Registry Payment?

All family physicians who provide longitudinal family medicine services to a patient panel are eligible for the Panel Registry Payment if they meet all the PAS participation requirements (see earlier question on eligibility). There is no requirement to have a minimum number of empanelled patients to be eligible for the Panel Registry Payment.

When is the deadline for physicians to submit their list of empanelled patients to MSP/Teleplan and to log-in and update their Panel Registry information?

Longitudinal family physicians with patient panels must submit their list of empanelled patients to MSP/Teleplan and log-in and update their Panel Registry information by January 31, 2024. This deadline applies to physicians paid under all payment models, including the LFP Payment Model, fee-for-service, blended capitation (e.g. Population Based Funding, Northern Model), and alternative payment contracts.

g. LFP Clinical Administration Time Code 98012 is not payable to the same physician for the panel submission and Panel Registry activities in note (b) after August 9, 2023.

Panel Maintenance

Bill the attachment code 98990 for each patient added to your panel
(this adds the patient to the PAS)

You will need to go into the PAS and 'remove' patients who have left your practice. They have not specified how often yet.

Our Divisions staff can help you and your MOA(s) develop a workflow in your office to manage updates.

There is only one attachment code now, regardless of billing model/contract

Clinic and Provider Registry Highlights

- Medical Director/Owner of multiple clinics may claim for each clinic
- FFS Medical Directors can claim for the payment (don't have to be LFP)
- Deadline for claiming the CPR payment?
To quote.... "not yet been confirmed"

Are family physician clinics that provide episodic care or focused practice eligible for the CPR Payment?

Clinics that provide longitudinal family practice services are eligible for the CPR Payment. These clinics may provide episodic or focused practice services *in addition* to longitudinal family practice services. Clinics that provide episodic or focused practice services exclusively are not currently eligible for the CPR Payment.

If you have missed the deadline for any reason, be sure to contact:

When is the deadline for clinics to update their clinic information on the CPR and to claim the CPR Payment?

The deadline for clinics to provide or update incorrect clinic information on the CPR is January 31, 2024.
