Overview: April 2024 - March 2025

The Sunshine Coast Division of Family Practice represents physicians who support the communities along the lower Sunshine Coast, including shíshálh Nation, Earl's Cove, Langdale, Madeira Park, Pender Harbour, Sechelt, Robert's Creek, and Gibsons.

Together, the members work to improve local primary care, increase local physicians' influence on health care delivery and policy, and provide professional support for physicians. The Division vision and mission statements and strategic priorities are attached. Membership is open to all physicians practicing or recently

retired on the Lower Sunshine Coast, including specialists and locums. Incorporated in November 2011, the Division currently has 91 members, including 36 family physicians, who work in six medical clinics.

Divisions of Family Practice are funded through the Family Practice Services Committee (FPSC), a joint committee of the BC Ministry of Health and Doctors of BC. Divisions of Family Practice are designed to enhance patient care, strengthen family physicians' influence on health care delivery and policy, and support professional satisfaction and well-being for physicians.



Message from the Chair

We remain the critical foundation of our health care system and provide incredible value for money in this system through the multiple roles we fulfill in all our communities. To name a few on the Sunshine Coast: lifetime longitudinal care from pregnancy/delivery to palliative care, home care, ER acute care, hospital inpatient and outpatient, chemotherapy, anesthesia, minor to major surgery and assists, Long Term Care, Opioid Agonist Therapy care, CBT group care, couple counselling, Doc in School care and multiple leadership and administration positions.

We see whoever walks through the door and are usually the first point of contact in this comprehensive care response. Exhausting and hugely satisfying if we maintain the balance between work, family and play time. We continue to acknowledge that the introduction of the LFP payment model marks a significant step in valuing longitudinal family practice and reinforcing our profession's importance. Your local Division has comprehensive dialogue with other regional and provincial Divisions, FPSC, VCH and the Ministry of Health on your behalf in supporting our voice at all of these levels.



The Board continues with a majority of physicians and one non-physician treasurer. Your Board Directors in the fiscal year remained as Anthony Barale, Julie Baxter, Brian Myhill-Jones, Sara Nimmo, Mark Wentzell, Ruby Yee and me. Afsaneh Moradi continued in her interim ED role so there was a much-appreciated stability for the Board after a turbulent previous year.

In August 2023, after three years of development, our Sunshine Coast Primary Care Network (PCN) service plan was approved by the Ministry of Health. We are now in the second year of a four-year implementation, focusing on community team-based care.

Over the next three years, we aim to hire 12 Allied Health Professionals, including mental health counselors, social workers, pharmacists, and specialized community nurses. Our goal is to improve access to primary care and increase the number of Sunshine Coast residents with a longitudinal care provider.

Our PCN Hub opened to house our new Allied Health Professionals (AHP) and we continue to seek FP and NP providers in developing a full clinic.

In this fiscal year we hired via the health authority: two PCN community mental health counsellors, one social worker and one pharmacist all of whom started working in the new PCN Hub in Sechelt at the end of the fiscal year with development of a simple AHP referral form for our primary care providers and have had good uptake of their services as team-based care evolves for supporting our FP/NPs and their patients. We have further AHP hires in the next two years including a PCN youth mental health counsellor, a Registered Psychiatric Nurse to support patients and caregivers dealing with dementia, a community dietician for shíshálh Nation and the Nation and Pender Harbour Health Centre will also search for other health providers.

Further PCN attributes include trauma-informed and culturally safe care. **We continue our engagement with the shíshálh Nation, and along with VCH, we are committed to the long process of reconciliation to address the significant harms of colonization.** The hospital-based blanket weaving project facilitated by Jessica Silvy was completed and planning for a health community Blanket exercise continued and occurred in the next fiscal year. We continue to promote and support san'yas Indigenous Cultural Safety training for our physicians and all new PCN hires.

The Division continues to collaborate with the Medical Staff Association (MSA) on the Recruitment and Retention Working Group to attract family physicians and nurse practitioners to the Sunshine Coast. We also hosted a joint Division Board/MSA Executive dinner meeting in furthering our joint effort to collaborate and avoid siloing of efforts. We have hired a Marketing and Communications company to develop material and support our public outreach and recruitment efforts.



The Division continues with member communication through a newsletter, consolidating key updates for members. A monthly 30min member virtual check-in has also been introduced with short topics of importance and open time for member issues as they are brought forward. Attendance has gradually increased as our membership recognizes the value in these brief regular check-ins.

We have started a Community Health Advisory Table (CHAT) of local community business leaders and politicians now with seven community leaders and Darnelda Siegers being elected as Chair, Afsaneh Moradi, Ted Krickan and myself. The vision is for this table to develop a community-led team-based care clinic to support our providers as a first step. We will also look for them to work with our Recruitment and Retention committee in promoting the Sunshine Coast in attracting all health care providers.

The Sunshine Coast Foundry planning continues, and the Division, which played a key role in supporting its application, will remain involved in all planning aspects. This is a major investment for children and youth. We also supported and facilitated a second Sunshine Coast CYMHSU Collaborative Care conference of all youth serving agencies on the coast in November/24, again with over 100 registrants.

As stated, we continue to collaborate with stakeholders, including the Ministry of Health, the shishalh Nation, FPSC, VCH, and community partners to drive improvements in patient care and physician support.

We extend our gratitude to the Board for their dedication and leadership, and to our Division and PCN staff, whose tireless efforts have been invaluable. We remain committed to advocating for our members and the communities we serve. Your ongoing engagement is critical to our shared mission.

Innovation: We are creative and open to change, seeking community-centred, team-based solutions.





Vicky Duffield, PhD, Shared Care Initiative Lead The Collaborative Mental Health Care Project aims to build capacity, competency and connectivity of the primary care system to better meet the mental health needs of patients and communities. And, to foster a collective understanding among providers and community of the impacts of trauma.

- Implemented a pilot embedding 2 psychiatrists in a primary care clinic.
- Facilitated 3 in-person and 1 online 8-week groups medical visits:
 Mindfulness-Based Stress Management and CBT Foundations (Mind Space).
- Dr. Rahul Gupta presented a MedTalk on trauma responsive care, in collaboration with Sechelt Hospital Foundation and VCH MHSU.
- Created and held 3 trauma responsive education workshops with healthcare providers.
- Hosted a Primary and Community Care Mapping workshop on adult mental health navigation and provider connections with healthcare and community providers.
- Developed and implemented a project evaluation plan with external evaluators.

Shared Care: Homebound Frail / Elderly Seniors

The Frail Elder project was implemented over 2 years and concluded in July 2025. The overall objective was to provide excellence in geriatric care and pursue the Quintuple Aim.

- Held discovery sessions with healthcare, shishalh Nation, social & community care providers to explore the current state of frailty care for older adults, and their caregivers, on the lower Sunshine Coast.
- Created a presentation synthesizing key learnings from the project's 2-years of work, as part of the knowledge sharing about the project's activities, outcomes, and next steps.

- Produced final project reports.

Primary Care Network

Some big wins for PCN last fiscal year include:

- Held a PCN public presentation in April, attended by over 80 community members.
- The new PCN Hub opened its doors to patients and staff in January 2025. New artwork in waiting room and signage was added to the door in February.
- Added 3 new allied health professionals to our team: Eric Kosiuk, PCN Clinical Pharmacist; Louise Chursinoff, our first PCN Social Worker; and Sarah White, our second PCN Counsellor who are all managing a full patient caseload.
- PCN allied health referral form has been created and added to all local clinic EMR's for ease of provider referrals
- Reallocated 0.3 FTE counsellor to Pender Harbour Health Centre.
- Ongoing engagement with primary care providers through lunch & learn sessions and virtual calls to share information about PCN services.
- Team-based care workshop took place in September, facilitated by Practice Support Program, Doctors of BC, with the goal of promoting collaboration and preventing siloed work.
- The PCN Pharmacist launches the use of virtual care platform Avee to help unattached patients access physician care. This platform is currently used by pharmacies on the Sunshine Coast.
- Hosted a dinner for community pharmacists to introduce the PCN Pharmacist service and welcome referrals. A referral form tailored specifically for community pharmacists was developed. As the first PCN to engage pharmacists in this way, we received positive feedback every respondent expressed interest in future gatherings.

- In recognition of Pharmacist Appreciation Month (March), we held pharmacist engagement sessions focused on seniors (a priority population) at various locations from Pender Harbour to Gibsons, marking the launch of the PCN Pharmacist self-referral service.
- Launched an NP/FP Search Engine Marketing (SEM) recruitment campaign in January in collaboration with Anchor Marketing, contract ending May 31, 2025. This campaign has produced many leads being followed up by the Recruitment Committee.
- Engaged in relationship-building with community organizations including the Sunshine Coast Hospice Society, Sunshine Coast Community Services, Sunshine Coast Resource Centre, and Gibsons Food Bank.
- Formed a Cultural Safety Committee in partnership with shishall Nation representatives, launching its first initiative to commission artwork by local shishall Nation artists for display at the PCN Hub, with the goal of strengthening connections with the local Indigenous community. Planning is underway for a Hub blessing and artwork unveiling event in September 2025.



- PCN admin team took SanYas Cultural Safety training course online and attended Cultivating Safe Spaces training workshop.
- Oversaw the migration and implementation of MedAccess EMR at the PCN Hub in February.
- A change request has been submitted to reallocate 0.75 FTE from a social worker to a youth counsellor specializing in child and youth mental health, in order to better support and serve this priority population.
- Received media coverage from the local newspaper, Coast Reporter, for two public presentations and the launch of the PCN Hub.

A special thank-you to Arbutus Clinic for hosting and supporting our Allied Health professionals until January 2025 when the Hub opened. We're grateful to everyone contributing to the Primary Care Network committees and working groups!
