**Summary of Job Description:**

Assess, triage, plan, implement, and evaluate nursing care delivery within a primary health interdisciplinary team service. Be the most responsible nurse for clinical services of an assigned panel of patients and clients. Assist and support family physicians, nurse practitioners, and other allied team members in care delivery. Provide health education and outreach, carry out screening and risk assessments, and coordinate population health programs for individuals and within a community context, for the catchment areas of Gordon Head/Shelbourne and Oak Bay.

**Required Qualifications:**

Registration with the BCCNM as a practicing Registered Nurse registrant.

Three years previous related clinical experience, or equivalent education, training, and experience.

Basic Life Support, Level C certificate.

Additional clinical competency courses are of benefit; experience and/or interest in service to seniors, and/or people with mental health conditions is an asset.
