- VDFP Financial Statements are audited each year by KPMG.
- The complete financial statements were emailed to members via the AGM meeting package and are available on the VDFP website.
- Daniel Healey from KPMG was in attendance.



Highlights:

- o PCN implementation was the focus this fiscal.
- Core infrastructure and ongoing programs continued, including work in Long-term Care and Transitions in Care initiatives.
- VDFP will be returning \$1.8M to the end of March 31, 2022, to Doctors of BC. We anticipate much of this funding to be repackaged and provided back to the division in 2022-23.
