Important Attachment Information

What is the PCN 0 Fee Attachment Code?

Western Communities -97608 Saanich Peninsula -97609

All family physicians (FPs) Nurse Practitioners (NPs) participating in a Primary Care Network (PCN) are required to submit attachment records so that the attachment of new patients can be counted as a key metric of PCN evaluation.

This "PCN attachment" is tracked using your 0 Fee code that is submitted to the Medical Services Plan Health Insurance BC through Teleplan on a one-time basis.

It is only to be submitted once for each patient at the time of their attachment to the FP or NP. The code is to be submitted when the patient is considered attached to the provider.

The process of attachment happens through an initial conversation between the new patient and provider to make sure there is a suitable fit and willingness by both parties to proceed. For more information, please contact Project/Attachment Coordinator Kim Brown at kim.Brown@sidfp.com

*Expanding and/or renovating may include design and contracting, including labour· permanent fixtures: materials for floor and wall coverings, ceilings, partitions, electrical, plumbing, fire protection and security.
