

KEY CHANGES TO THE GUIDELINE AND ALL RELATED DOCUMENTS:

- ► Incorporation of funded NIPT in the screening process
 - ★ New web page <u>bcprenatalscreening.ca/NIPT</u> with information and lab requisitions (both funded and self-pay)
- ▶ Recommendations for pregnancies with soft markers on detailed ultrasound
- ▶ If patient chooses to have self-pay NIPT, an NT ultrasound and SIPS/IPS is **not** indicated
- ▶ Detailed ultrasound (18 20 weeks) is the best screen for Neural Tube Defect for those patients who choose to have self-pay NIPT, or no screening for Down syndrome

TO IMPROVE SCREENING PROCESS, TIMING IS EVERYTHING

Given the turn-around time for SIPS/IPS/Quad results, it is imperative that the second blood draw (Part 2) be done as early as possible, **ideally between 15 weeks 2 days and 16 weeks 6 days**. This will allow maximum decision-making time for your patient if results are positive. Current turn-around-time for NIPT results is 9 days with 2% of patients needing a redraw.



Eligibility criteria for funded NIPT:

- 1. Has received a positive screen result from SIPS, IPS, or Quad for Down syndrome or trisomy 18 (authorization code provided by C&W prenatal screening lab)
- 2. Has had a previous pregnancy with trisomy 21, 18, or 13*
- 3. Trisomy 21/18/13 risk greater than 1/300 based on serum screening result & ultrasound marker(s)*
- * A referral to Medical Genetics (Vancouver or Victoria) is required for #2 and #3 (authorization code provided by Med Gen)

Note requirements for laboratory requisitions for screening (online at bcprenatalscreening.ca):

- SIPS/IPS/Quad Patients **MUST** bring the completed requisition(s) with them to any local blood collection facility (e.g., Hospital Outpatient Labs or local LifeLabs/BC Bio community labs)
- Funded NIPT Both the Patient and Ordering Provider **MUST** sign the Dynacare Harmony requisition to prevent delays in sample processing. (List of NIPT-specific collection sites at <u>bcprenatalscreening.ca/NIPT</u>)
